ITEM 6 NEW BUSINESS

6.A Resolutions R2017-004 & R2017-005 To Approve PEG Grants
Resolution R2017-004 for the renovation of the Rain Garden at Sehmel
Homestead Park: Commissioner Iverson noted concern regarding the amount of the grant.

Karen Larson reviewed her role with PenMet Parks and reviewed the need for a restoration project of the rain garden surrounding the pavilion. She provided the board with a presentation for the PEG Grant. She indicated that the low bid is \$20,000 to remove the current soil, fix drainage, and add new soil with correct grading. Volunteers will then do the planting and mulching.

Commissioner Iverson made a motion to amend resolution R2017-004 to not exceed \$22,000. Commissioner Nixon seconded the motion. Commissioner Grimmer then called for a vote, and the motion passed 4-0.

Commissioner Nixon then made a motion to pass the amended resolution R2017-004. Commissioner Iverson seconded the motion. Commissioner Grimmer called for a vote, and the motion passed 4-0.

Resolution R2017-005 for the installation of culverts and additional drainage at Sehmel Homestead Park: Commissioner Iverson noted concern that there is no checklist included with the resolution. Commissioner Grimmer then asked for a motion to approve R2017-005. Commissioner Iverson motioned, and Commissioner Nixon seconded the motion.

Commissioner Grimmer then called for a vote, and the motion passed 3-0-1. Commissioner Iverson abstained from the vote.

ITEM 7 COMMENTS BY BOARD

Commissioner Iverson noted concern regarding the lack of boat launches on the peninsula. He stated that the Port Commission would possibly be willing to partner with the park district and support a launch.

Terry Lee discussed the Fox Island boat ramp. He noted citizen concerns regarding traffic on the bridge. Because of previous threatened lawsuits, the project was dropped. Mr. Lee also noted that there is interest by Derek Kilmer in additional ramps.

Ron Martinez gave the board an update on recent projects, including Parks Appreciation day and preparing for summer. He also noted upcoming projects, including replacing the carport at Wollochet Estuary Park and potential projects to perform at the Rosedale Community Hall.

Mr. Martinez also requested to use tractor replacement funds to purchase a broom for the new turf fields. Commissioner Iverson asked him to bring some numbers and options to a future meeting.
